Dual Admission Agreement Mount Aloysius College's Community Counseling Program and Saint Francis University Behavioral Science, Psychology, Social Work and Sociology Programs

THIS AGREEMENT, Made this 7th day of March 2019 by and the Mount Aloysius Master's in Community Counseling (hereinafter referred to as MAC) and Saint Francis' Behavioral Science, Psychology, Social Work and Sociology Programs (hereinafter referred to as SFU).

Overview:

Advantage of Dual Admission:

- SFU students may apply upon entrance to (or during) the SFU Program and will be guaranteed admission to MAC as long as the admission criteria are met upon graduation. The student will receive a letter from MAC indicating conditional acceptance into the Master's in Community Counseling program when he/she files the intent form.
- The dual admissions process provides a seamless transition between the SFU Program to MAC Community Counseling Program with maximum use of previous credits. The student will not be put on an admissions waiting list,
- The admission fee for application to MAC will be waived,
- Students will benefit from specialized academic advising that meets the unique need of counseling students. The student will have an academic advisor at SFU and at MAC.
- The student will be granted 15% tuition discount for the duration of the graduate program at MAC.
- Qualified students may take up to 6 specified Community Counseling graduate credits prior to completion of SFU Program.

Each student must complete an intent form (which will serve as the admission application) in order to notify both the SFU Program and MAC Counseling Program of the intent to complete a Masters in Community Counseling. Once MAC is notified of this intent, a letter of conditional acceptance will be sent to the student and will name an academic advisor at MAC. The intent form can be completed at the beginning of the SFU Behavioral Science, Psychology, Social Work and Sociology programs, or at any point prior to graduation, and it will guarantee the student admission to MAC for up to one year after completing the program at SFU. Any student who does not complete an intent form may still apply to MAC, however a seat will not be guaranteed, and he/she will compete among the other applicants for admission. Students may void the dual admission intent at any time through written notification to both MAC and SFU.

*This Agreement pertains to all Graduate Community Counseling Programs and Certificates offered by MAC.

Termination Process: This Agreement, unless terminated as hereinafter set forth, shall be automatically renewed as of August each year for an additional time of one (l) year, with such changes, if any, as may be mutually agreed upon by SFU and MAC. The Agreement may be discussed annually by the School's Articulation Committee (MAC). This ongoing Agreement may be terminated by either party upon a 90-day written notice of cancellation or termination or by written mutual agreement.

Application Process: The dual admission application form can be obtained from faculty advisor at SFU or from the Admissions Office at MAC. When the SFU program is complete, the admissions form along with a transcript will be required by MAC. The application fee will be waived.

Criteria for Admission: Each student must meet the MAC admission standards and enroll within one year of graduation from SFU. The student must have a minimum grade point average of a 3.0 previous coursework to be admitted. The intent form will serve as the application.

This agreement is effective as of July 1, 2019.
