



## Dual Admission Agreement Saint Francis University, MSN L/E Program and Mount Aloysius College's RN-BSN Program

THIS AGREEMENT, Made this <u>1st</u> day of <u>October</u>, 2018 by and between the <u>Saint Francis University</u>, <u>MSN L/E Program</u> (hereinafter referred to as SFU) and <u>Mount Aloysius College's School RN-BSN Program</u> (hereinafter referred to as MAC).

## Overview:

## Advantage of Dual Admission:

- Nursing students may apply upon entrance to (or during) the MAC RN/BSN Program and will be guaranteed admission to SFU as long the MSN L/E admission criteria are met upon graduation. The student will receive a letter from SFU indicating conditional acceptance into the MSN L/E program when he/she files the intent form.
- The dual admissions process provides a seamless transition between the MAC RN-BSN Program to SFU MSN L/E Program with maximum use of previous credits. The student will not be put on an admissions waiting list.
- The admission fee for application to SFU will be waived.
- Students will benefit from specialized academic advising that meets the unique need of nursing students. The student will have an academic advisor at MAC and at SFU.
- The student will be granted 15% tuition discount.
- Qualified students may take up to 6 specified MSN graduate credits prior to completion of MAC RN-BSN Program.

Each student must complete an intent form (which will serve as the admission application) in order to notify both the MAC RN-BSN Program and SFU MSN L/E Program of the intent to complete the MSN L/E Degree in Nursing. Once SFU is notified of this intent, a letter of conditional acceptance will be sent to the student and will name an academic advisor at SFU. The intent form can be completed at the beginning of the MAC RN-BSN Program or at any point prior to graduation, and it will guarantee the student admission to SFU for up to one year after completing the program at MAC. Any student who does not complete an intent form may still apply to SFU, however a seat will not be guaranteed, and he/she will compete among the other applicants for admission. Students may void the dual admission intent at any time through written notification to both SFU and MAC.

**Termination Process:** This Agreement, unless terminated as hereinafter set forth, shall be automatically renewed as of August each year for an additional time of one (l) year, with such changes, if any, as may be mutually agreed upon by the MAC and SFU. The Agreement may be discussed annually at the School's Advisory Committee Meeting (SFU). This ongoing Agreement may be terminated by either party upon a 90-day written notice of cancellation or termination or by written mutual agreement.

**Application Process:** The dual admission application form can be obtained from faculty advisor at MAC or from the MSN L/E Program Office at SFU. When the RN-BSN program is complete, the admissions form along with a transcript will be required for admission to SFU. The application fee will be waived.

**Criteria for Admission:** Each student must meet the SFU admission standards and enroll within one year of graduation from MAC. The student must have a minimum grade point average of a 3.0 in previous coursework to be admitted. The intent form will serve as the application.
